Emergency Response

Description of System

The Collier Township Municipal Authority's Wastewater Collection System consists of approximately 53.6 miles of pipe lines and manholes, and two (2) pumping stations. The Authority's System provides sewage service to approximately 2,525 customers and purchases Sewage Treatment from the Allegheny County Sanitary Authority (ALCOSAN).

Assessment of Equipment and Personnel

The Collier Township Municipal Authority personnel staff consists of the Office Administrator, Michele A. Krugh, and Assistant Office Administrator, Lori Thompson, (Office 412-279-4941, Fax 412-278-2001). The Authority does not own construction equipment or maintenance vehicles. All maintenance and repair work and construction of new lines are by contract with maintenance and construction contractors.

Collection System Problems

(Separate) Sanitary Sewer Overflows (SSO's) from diversion chambers, manholes and sewage backups into basements are the types of emergency situations which generally occur. On occasions, pump station malfunctions also cause overflows at the stations wet well (manhole). Overflows are generally reported by local residents or passerby's, who either contact the Authority's office directly or the Collier Township Police Department, or Stan Yablonski, Collier Township Road Supervisor (Office 412-429-6811; Cell 412-728-7372).
